On March 19, 2025, the Educational Policy Subcommittees—Curriculum Subcommittee, General Education Committee, and Graduate Studies Committee - submitted a memo proposing updates to the current Credit for Prior Learning Policy, replacing the current campus-specific language with the systemwide policy adopted by the CSU.

The CSU system updated the Credit for Prior Learning policy on August 22, 2023. The Curriculum Subcommittee started reviewing Cal State LA policy for needed revisions the following Spring but did not complete it until this Spring, 2025. In the process, the CSU provided a revision effective March 4, 2025, to reflect the updates to the general education policy.

Credit for Prior Learning is an important policy aimed at supporting students who, through either campus-originated exams, standardized external exams (AP, IB CLEP), experience, learning acquired outside of traditional higher education, or education acquired through military service, have earned the opportunity to receive unit credit toward degree completion. Given that so many high school graduates or community college students enter the workforce, military, or other experiences before deciding to begin or complete their degree goals, it is critical that these students have a fair and appropriate opportunity to seek unit credit for courses with outcomes equivalent to those they already met and maintained.

On March 26, the EPC met to review the memo and the proposed modifications to incorporate the system language. The EPC agrees with the modifications proposed by the subcommittee to use the language of the system policy to replace campus policy.

Here are all the proposed modifications:

- Line 1: Credit for Prior Learning is proposed as the title for the policy that includes credit for examinations, credit for knowledge acquired through experience, and credit for learning acquired through non-traditional higher education and through military service.
- Lines 5-13: Introductory language has been added to the policy.
- Lines 18-22: Language is updated to reflect where the information should be published and to use the term "shall" as made clear by the CSU policy.





- Lines 34-35: There is a limit to the number of courses that can be taken as credit by examination. WSCUC guidance does not allow for more than 25% unit credit for prior learning assessment (for example 30 units for undergraduate degree of 120 units).
- Line 44: System-wide exams was removed as there do not seem to be any recognized in system policy.
- Lines 64-73: System language replaces current language.
- Lines 78-79: System language replaces current language.
- Line 81: System language replaces current language.
- Lines 84-99: System language replaces current language.
- Lines 101-168: System language replaces current language.
- Lines 170-177: System language replaces current language.
- Lines 178-238: System language replaces current language.
- Line 239: Removed "and/or GE Block E credit" language.
- Line 243: Removed "and/or GE Block E credit" language.
- Lines 246-283: WSCUC Guidance is included to provide broadest parameters for CPL across all areas included in the policy.

- Prior to taking the examination, approval of the chair of the department/division chair or
 school director concerned and the instructor of the course, is required. Forms for approval
 may be obtained from the departments/divisions/schools. One copy of the approval to take
 the examination must be filed with the Records Office, prior to the eighth week of the
 semester in which the examination is taken.
- Credit by examination is restricted to regular undergraduate and graduate courses listed in
 the General Catalog; <u>while there is no limit to the number of courses that can be taken as</u>
 <u>credit by examination</u>, these units do not count as residence credit.
- Credit by examination is not treated as part of the student's work load and is not considered
 by the Veterans Administration in the application of their regulations.
