Can the Communications Office and the President use the language that we've worked so hard at for the last seven years to honor the inclusion of lecturers when referring to faculty? Re: the email about the hiring freeze, can this be clarified: "How does this impact temporary or adjunct hiring? Temporary adjunct or part-time hires will be subject to the same scrutiny as full-time positions. Exceptions may be granted for critical, academic, or operational needs." Can clarification be provided about recent contracts and spending in light of our austerity on campus (i.e., private security, graduation and rebranding)? INTENT TO RAISE QUESTIONS	3.	3.1	Senator Porter announced her intent to raise the following questions: (Supported by NSS student affairs committee and leadership of research training) Many students express frustration and anxiety regarding the lack of access to financial aid staff including not receiving responses to emails, not being able to reach anyone by phone, and excessive wait times for in-person consultation that at times exceed several hours. The lack of expert advice from financial aid often leads to late enrollment or inability to enroll as well as financial instability. Similarly, faculty directing student training programs also experience an absence of responses and guidance when they approach financial aid to better serve their students. What is the short-term and long-term plan of the University to improve communication with and accessibility to financial aid?
		3.2	Senator Baker announced her intent to raise the following questions: President Eanes and Provost Bippus During the 2023/2024 fiscal year, the last publicly posted budget, CSULA spent \$1,621,466 on police. In addition, in May the campus paid close to 2 million dollars for private security services. Given the campus deficit and cuts to the instructional budget, the additional spending on private security seems excessive and effectively increases the policing budget on campus to around 3.5 million dollars. Since this expenditure is outside of the regular campus budget, it defies the President's commitment to budgetary transparency, as it more than doubles the campus budget for police without public scrutiny. With this increase, the campus is paying almost 5 times as much for policing as it is for student mental health services or for support for students with disabilities. There is no evidence that the additional private security is necessary or is making the campus safer. When will the campus end the contracts with private security companies? In the service of budgetary transparency, how much will the campus pay for private security before all contracts are cancelled?
