# course and articulation data exports

Campuses can import data for use in degree audit and student planning systems, as well as in CSU and UC undergraduate admissions application systems.

\*ASSIST does not extend to private, out-of-state or international colleges or universities.

#### transfer search site

Users are able to search for course transferability and/or articulation information across multiple colleges and universities.

## course submission and review process

CCC courses are submitted and reviewed for transferability and articulation.

ASSIST users access millions of articulation agreements and transferability lists each year:

#### **Articulation agreements**

show how courses at a CCC may satisfy specific department or major requirements at a CSU or UC campus.

#### **Transferability lists**

display CCC courses that are transferable to CSU or UC, as well as which courses may be used to satisfy elective or general education requirements upon transfer.

## **Transfer Students**

Articulation is the process where faculty reviews similar courses from other institutions to determine if the course content is sufficiently comparable to warrant formally accepting one for the other.

The ASSIST program is designed to help students and advisors work together to find the right path to transfer from the public California Community College (CCC) to California State University (CSU) and the University of California (UC). ASSIST is designed to clarify how California transfer students can use the courses they take at community colleges to meet electives, general education requirements, and core requirements on CSU or UC campuses.



# What is the Transfer Success Pathway program?

The Transfer Success Pathway (TSP) program is a transfer program that allows students to enter into an agreement with a CSU campus that guarantees admission for a future term.

Guided by the Governor's Council for Postsecondary Education's "Recovery with Equity" report and the postsecondary education trailer bill AB 132, the Transfer Success Pathway program was set up to address potential inequities because of the COVID-19 pandemic, issues with academic preparation and other challenges facing high school students.



Graduated high school in 2024 or prior.

First-time freshman entering a community college

- Not CSU eligible at HS graduation or
- Not able to attend a CSU due to financial or personal reasons or
- Redirected and chose not to attend a CSU


## TSP Agreement Facts

- PCC leading with a total 308 agreements




# Top 10 Majors Selected For TSP Agreements
