

Semester & 30-Day Permits are only available on-line at calstate-

la.edu/parking. Visitor and daily parking available from the Pay-by-Phone App using codes listed on signage, or from pay stations located in designated parking lots.

This brochure provides helpful information regarding the use of your parking permit, parking regulations, and other transportation services offered by Cal State L.A. The following guidelines apply when parking on campus:

- Vehicles must be registered to a valid parking permit when parked on University property, unless you are parked in a timed loading zone.
- Parking is enforced 24 hours a day, 7 days a week.
- Parking regulations are always in effect and parking citations may be
- issued during administrative holidays and semester breaks.
- Unless specified, permits are not valid for overnight parking.
- Drivers entering the Cal State L.A. campus must comply with the rules and regulations set forth, pursuant to California Vehicle Code and Administrative Procedure 402.

Basic Parking Rules and Regulations

The responsibility for finding a legal parking space, as well as knowing where and when a parking permit is valid, rests with the vehicle operator.

The purchase of a parking permit does not guarantee a space to park and the inability to locate a space is not considered a valid justification for violating University Parking Regulations.

Overnight parking is prohibited except in Lot 5 and Paseo Rancho Castilla east of Mariondale Avenue to Hellman Avenue bridge, with valid permit only. Overnight parking in other lots is prohibited unless authorized by University Police. Personal notes or explanations left on vehicles are not substitutes.

A parking citation may be issued without benefit of prior warning to any vehicle on University property under the following conditions:

- Parking without a permit in any designated parking space.
- Parking without properly registering the correct plate number to a valid permit.
- Parking with an invalid, expired, or revoked permit.
- Parking beyond the limit in a time-controlled zone, which is enforced 24 hours a day, 7 days a week.
- Parking in a parking space that has been created by the painting of two lines
- Parking at any time in an undesigned are (i.e., red zones and curbs, blocking driveways, walkways, or ay other unmarked place).
- Parking in a disabled stall without a valid Cal State L.A. permit and DMV placard.

Parking Permits

Semester and 30-day permits are available on-line through your MyCalState-LA or at calstatela.aimsparking.com

Parking permits are virtual and use the license plate number in lieu of a hangtag. All vehicles parking on campus must be registered to a valid Cal State L.A. parking permit or the purchase of a parking permit from the Pay-by-Phone app, or from a parking pay station located in parking areas. Please be sure your license plate is correct when purchasing or registering your vehicle. Vehicles with incorrect plate numbers registered are subject to citation.

Housing Parking

Housing residents needing a parking permit must purchase a Resident Parking Permit online using their parking portal. The permits are virtual and there is no physical permit to display. Parking for residents is available in Lot 5 and along Paseo Rancho Castilla, east of Mariondale and up to the Hellman Ave bridge.

Rideshare Program

Walking Escort Services

Eagle Patrol offers walking safety escort services. Requests for escorts can be made 24 hours a day by calling University Police at (323) 343-3700.

EV Charging Stations

Level 2 EV stations are located in Structures A, B, C, and E as well as in Lot 3, Lot 6, and Lot 10. Level 3 EV stations are located in Structure B (Level B) and in Structure E (Level 1). Passenger Loading and Unloading

Uber and Lyft passenger zones are located at the south end of campus across the Transit Center, at the Univesity Student Union, and in Housing. Inner Campus and Extended Loading permits

For access to inner campus to deliver equiipment or large loads, an inner campus permit is required. Restrictions apply when entering campus with a vehicle.
