Installment Payment Plan (IPP) - 3 Payments

The IPP enrollment fee is \$33.00* and must be paid with the first installment at the time of enrollment into the plan. The second installment is due 30 days after the first due date, and the third installment is due 60 days after the first due date. **The last day to sign up for this plan is July 9**th, **2025.**
